The meeting was called to order at 2:00 p.m. by Chairman Beaumont after ascertaining that the Notice of Meeting had been posted in accordance with the law. Commissioner Moses gave the invocation.

Mr. Ike Mills asked for more detailed information on Agenda Item A, Consider Approval of Interlocal Agreement with the City of Port Arthur to Spread Excess Dirt at the City of Port Arthur Landfill as a Result of the Groves Detention Pond Project, and Agenda

Item B, Consider Approval to Advertise for Request for Proposals for Annual Financial Statement and Single Audit Services.

### Minutes of Meeting No. 2444

The Minutes of Meeting No. 2444 were approved as read.

Consider Approval of Interlocal Agreement with City of Port Arthur to Spread Excess Dirt at the City of Port Arthur Landfill as a Result of the Groves Detention Pond Project

Consider approval of Interlocal Agreement with the City of Port Arthur to Spread Excess Dirt at the City of Port Arthur Landfill as a Result of the Groves Detention Pond Project. Mr. Toby Davis stated that the Groves Detention Pond Project is funded through the FEMA Hazard Mitigation Grant Program. The District acquired Taft Elementary located at Taft Avenue and Hwy 73. The project will be constructed on the previous site of the Taft Elementary and on an adjacent tract of land owned by Total. Total intends to give DD7 an easement over this tract for the construction of the project. The project has been designed. An environmental assessment was completed and approval by FEMA. The District also had other environmental and cultural issues that were addressed, submitted to and approved by FEMA. During the construction of the detention pond, the excess fill material (dirt) has to be disposed of. Total does not want the fill material. The second option is to place the fill material at the District's Halbouty detention pond. The back up option is the City of Port Arthur City Landfill. An agreement was made with the City of Port Arthur and it's engineering department to dispose of the excess fill material at the City of Port Arthur Landfill. The Interlocal Agreement states that if the City of Port Arthur has equipment and an operator working at the landfill when/if the District needs to dispose of the fill material the City of Port Arthur will move the fill material. If the City of Port Arthur does not have equipment and operator out at the landfill, the District will supply

the equipment and operator to move the fill material. Commissioner Moses moved to approve the Interlocal Agreement with the City of Port Arthur to Spread Excess Dirt at the City of Port Arthur Landfill as a Result of the Groves Detention Pond Project. Commissioner Vincent seconded the motion. The motion carried.

<u>Consider Approval to Advertise for Request for Qualifications for Annual Financial Audit Services</u>

Mr. Sims stated that the District has been using the same audit company for its annual financial audit for several years. Request for proposals will ensure that the District is using the right firm for its needs. In the last three years, the audit report has been completed by the current firm later and later. The request will be advertised in the Port Arthur News and invitations will be sent to the four firms in the region that perform government entity audits seeking proposals. Commissioner Vincent moved to approve Advertising for Requests for Qualification for Annual Financial Audit Services.

Commissioner Champagne seconded the motion. The motion carried.

The invoice from Epic Engineering (W-Industries) submitted for payment is for mobilization, performance and payment bonding, and the 25% completion milestone of the PS #16 electrical re-wire in the amount of Seven Hundred Thirty Thousand Forty-Eight and 31/100 (\$730,048.31) Dollars. Commissioner Champagne moved to approve Pay Request No. 1 from Epic Engineering (W-Industries) for the design/build of the Supervisory Control and Data Acquisition (SCADA) System Project in the amount of
